

Phi Delta Chi Pharmacy Fraternity Grand Council Business Rules

- 1. Before the Opening Business Session, Collegiate and Alumni Chapters shall report their Delegates to the National Office. Any disputed representation will be settled by a Credentials Committee of three Brothers designated by the Grand President.
- 2. Only Brothers officially designated as Delegates are permitted to make motions, offer seconds, bring up items for discussion, or vote on resolutions.
 - To maximize the number of delegates who may speak, each Delegate may speak for 2 minutes, unless allowed an extension by the Presiding Officer.
 - A Brother may not speak a second time on the same issue if another Brother who has not yet spoken asks to be recognized. No Brother may speak more than twice on the same issue, except by unanimous consent of the Presiding Officer.
- 3. To speak on an issue:
 - Delegate shall approach a microphone and wait until recognized by the Presiding Officer
 - Once recognized the delegate will give their name and chapter affiliation (John Doe, Alpha Collegiate).
 - Succinctly make and/our motion or explain your position.
- 4. Discussions on motions and resolutions shall be limited to not more than 2 minutes for each speaker. Discussion on any one question shall be limited to not more than 20 minutes. Both time limits may be changed by appealing to the Presiding Officer or by two-thirds vote of the Grand Council delegates present.
- 5. Discussion on issues may be tabled upon a two-thirds vote of the Grand Council delegates present.
- 6. No resolutions introduced by the Reference Committees shall be voted upon until the Interim Business Session.
- 7. Elections for Grand Office will follow procedures adopted by the Executive Council.
- 8. Votes shall be taken by the anonymous voting feature of the Internet meeting service, unless a different method is ordered by Grand Council or required by the rules. When required or ordered, other permissible methods of voting are by electronic roll call or by audible roll call. The Presiding Officer's announcement of the voting result shall include the number of Delegates voting on each side of the question and the number, if any, who explicitly respond to acknowledge their presence without casting a vote. Business may also be conducted by unanimous consent.
- 9. Any matter not covered by the Phi Delta Chi Constitution and Bylaws or these Grand Council Rules shall be decided in accordance with the latest revision of Robert's Rules of Order. The Grand President shall make the final decision as to all matters of parliamentary procedure with the counsel of the Grand Council Parliamentarian.
