





NOMINATIONS FOR THE ALBERT B. PRESCOTT PHARMACY LEADERSHIP AWARD ARE DUE NOVEMBER 4TH

ACCEPTING NOMINATIONS

The Albert B. Prescott Pharmacy Leadership Award







The Albert B. Prescott Pharmacy Leadership Award, first presented in 1987, is given annually to a young pharmacist no more than 10 years after receipt of his or her PharmD. The recipient shall have demonstrated exemplary leadership qualities as a young pharmacist indicative of someone likely to emerge as a major leader in pharmacy over the course of his or her career.

The award is administered by the Pharmacy Leadership & Description Institute (PLEI) and sponsored by Phi Lambda Sigma. From its beginning, this has been a profession-wide recognition, not restricted to any fraternal group or practice setting.

The 2023 Prescott recipient, who must have received his or her PharmD in 2013 or later, will receive a \$2,000 honorarium. He or she must give an address during the 2023 American Pharmacists Association annual meeting in Phoenix, AZ (March 24-27, 2023) and prepare a text based on the address that is suitable for publication in the Journal of the American Pharmacists Association.

We invite you to nominate a young pharmacist for this award. Self-nominations are also permitted. Nominations may be submitted online via the following website: https://plei.org/prescott/.

Nomination materials include:

- · Curriculum vitae (CV) of the nominee
- Letter of nomination
- Supporting letters of recommendation (up to 5 will be accepted)

Nomination materials must be received by November 4, 2022. Late submissions/letters will not be considered.

COURTNEY PURCELL (OMEGA) RECEIVES INAUGURAL SCHLEGEL LEADERSHIP DEVELOPMENT AWARD



The Pharmacy Leadership and Education Institute (PLEI) is proud to announce Courtney Purcell of Omega Chapter as the inaugural recipient of the John F (Jack) Schlegel Leadership Development Award.

Courtney Purcell received her PharmD from the University of Tennessee Health Science Center. Courtney led the Omega chapter as its WVC and then WCC and played a major role with the Grand Council 2021 Planning Committee. Dr. Purcell was a Dean's List student, a member of the Imhotep Leadership Society and a member of the Phi Lambda Sigma Leadership Society and served as a Student Government representative.

Courtney received her Bachelor of Science degree from the University of North Georgia in 2018 and has worked in several pharmacy settings during her education and regularly volunteers in many professional, collegiate, and community activities. She is currently working in her Postgraduate Year One (PGY1) residency at Rush University Medical Center in Chicago with a goal of becoming a board-certified Emergency Medicine pharmacist working in health informatics.

In the letters of recommendation submitted in support of Courtney's nomination, she was praised as "a natural leader, gifted with a strong ability to overcome adversity and inspire," and has been recognized for outstanding efforts in internship positions for going above and beyond assigned roles. When the last [Leader-Development Seminar] LDS program was cancelled due to Covid, she spearheaded efforts to create a virtual LDS that allowed for 40 PDC Brothers from multiple chapters to participate in a virtual leader development conference while the world was still shut down.

As the recipient of the Schlegel Leadership Development Award, Courtney will receive a crystal award and a \$1,000 honorarium. PLEI Director Dennis B. Worthen chairs the PLEI Awards Committee. About John F. (Jack) Schlegel Dr. Schlegel received his Bachelor of Science in Pharmacy in 1967 and his Doctor of Pharmacy in 1972 from the University of the Pacific. He received a Master of Science in education at the University of Southern California in 1980. From 1967 to 1975, Schlegel served as Chief Pharmacist, Instructor, and Director of Pharmacy Admissions at the University of Southern California. In 1975 he joined the staff of the American Association of Colleges of Pharmacy and eventually became CEO. Schlegel assumed the role of CEO of the American Pharmacists Association in 1984 when he was just 39 years old, serving until 1989. He then started his own management consulting firm that focused on leadership development and improving the governance and management of non-profit organizations. Over the next 15 years he worked with more than 350 organizations nationwide. In 2000, when his wife Priscilla retired, they relocated from Washington, DC, to Florida, where they now spend their time enjoying the cultural arts and as major philanthropists in support of them.
